NOTE ON THE PROCESS OF DUE DILIGENCE

Following details summarize our process of Due Diligence with respect to the proposed Initial Public Offer of YASH HIGH VOLTAGE LIMITED ("Issuer") on BSE SME PLATFORM OF BSE LIMITED:

Current business background about the operational structure and the Business Strategy:

We visited the office and factory premises of the Issuer.

- 1. Inspected the office and factory premises, infrastructure, staffing systems and procedures w.r.t, the Company's business. Also examined various documents including those relating to litigations, approvals, disputes with statutory authorities and other material documents in connection with the finalization of the Draft Red Herring Prospectus pertaining to the said offer.
- 2. Had discussions with the Board of Directors, KMP's including the support staff regarding the business operations and related activities of the Company and gone through other documents / website in order to further understand the actual procedures of business.
