Re: Scrutinizers' Report on Postal Ballot held through remote E-voting in respect of passing of resolution set out in the notice dated January 09, 2025 pursuant to section 108 & 110 of the Companies Act, 2013 read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014

1. I, Kashyap Shah, Proprietor of Kashyap Shah & Co. Practising Company Secretaries, having office at B-203, Manubhai Towers, Sayajigunj, Vadodara 390020 have been appointed as Scrutinizer by the Board of Directors at its meeting held on January 09, 2025, pursuant to Section 108 & 110 of the Companies Act, 2013 read with Rule 20 & 22 of the Companies (Management and Administration) Rules 2014 (herein after referred to as Rules) for scrutinizing the Postal Ballot held through remote e-voting process, in respect of resolution contained in the postal ballot notice dated January 09, 2025 ('the Postal Ballot Notice').
2. - A. Notice of Postal Ballot was transmitted to the members of the Company on February 3, 2025, only to those members whose e-mail ids were registered with the Company / Depositories, as on January 31, 2025, which was cut off date for sending postal ballot notice.
- B. The above notice was intimated to the Stock Exchange BSE Limited on February 3, 2025 and also placed on the website of the Company (www.yashhv.com) forthwith when it was sent to members.
- C. The notice clearly indicated the process and manner for electronic voting during the remote e-voting period and also provided instructions for the login ID and generating password and casting of vote in a secured manner.
- D. As per requirement of the Companies (Management and Administration) Rules, 2014, the public advertisement with respect to dispatch of postal ballot notice and intimating date and time of commencement and closing of remote E-voting have not been published in English and in regional language news papers.
- E. The remote e-voting period remained open from Thursday, February 06, 2025 (9.00 A.M. IST) to Friday, March 07, 2025 (5.00 P.M. IST).
- F. The members of the Company holding shares as on "Cut-off" date i.e. January 31, 2025 were entitled to vote on the resolution mentioned in the notice of postal ballot dated January 09, 2025.

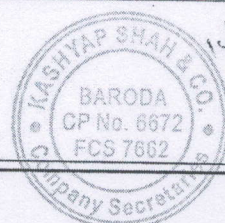
